Subject: Certificate of compliance REACH and RoHS

Dear Customer,

According to the Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), the products that we provide have been defined as Articles and, therefore, we have the duty to provide information along the supply chain.

According to Art. 33 of this Regulation, any supplier of an Article has the duty to provide information about any substance of the candidate list-SVHCs (updated 05/02/2026 253 substances) contained in the articles supplied or imported, which contain such a substance in a concentration above 0.1% (weight by weight) of the article, providing enough information to allow the safe use of the article.

We are keeping in touch constantly with our own suppliers to keep this information updated. On the other hand, we pay maximum attention to the updates of the List of Substances of Very High Concern (candidates to be included in Annex XIV), to keep this information updated.

Therefore, we assume that our products do not contain any of the candidate list-SVHCs above the concentration limits set forth obliging us to inform customers, except for those which have lead (Pb) according to the standards of the materials.

The European Directive 2011/65/UE (RoHS3) and its amendment 2015/863 aims to restrict the use of 10 hazardous substances in electronic and electrical equipment sold in European Union countries: Lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ether (PBDE), Bis(2-ethylhexyl) phthalate (DEHP), Butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP), Diisobutyl phthalate (DIBP).

On the base of the information communicated by our suppliers, we confirm that the products sold by MGB are in compliance with requirements of the ROHS legislation. They do not contain any of these substances at the exception of Lead which is present in certain of the raw materials machined

by MGB. The concentration of Lead do not exceed the values fixed in the exemption 6 of the Annex III of the directive :

«6a : Lead as an alloying element in steel for machining purposes and in galvanised steel containing up to 0,35 % lead by weight

6b : Lead as an alloying element in aluminium containing up to 0,4 % lead by weight

6c : Copper alloy containing up to 4 % lead by weight. »
